Introduction

The Community Empowerment (Scotland) Act 2015 sets out requirements for community planning which is an important process that helps public agencies, the third sector and communities to work together to plan and deliver better services. It also helps to improve local areas in ways that will make a difference to people living there. As the name suggests, participation of communities is of vital importance to any community planning work. Under the Community Empowerment (Scotland) Act 2015 The Orkney Partnership is required to undertake what is known as locality planning. In short, locality planning is one of the ways that communities can become involved in community planning and influence decisions within their area. A locality plans purpose is to identify particular geographic areas that are experiencing issues or are relatively disadvantaged in any way and then sets out what can be done to improve this.

In 2016/17 The Orkney Partnership Board chose the non-linked isles as one of the first geographic areas to be looked at in Orkney to develop a locality plan. The Place Standard model was chosen as the basis for a survey which would allow respondents to inform the ongoing work of the partnership by helping to develop an understanding of the local issues and circumstances on each island. The Place Standard¹ model allows participants to rank a series of categories on the physical, social, and environmental characteristics of their area, as well as the local economy. It is then possible to summarise the findings of the survey into one image (a radar charts) which shows how respondents have ranked each category, which is easily comparable across different areas. The results of the 2017 consultation on the non-linked isles were used to inform the development of The Orkney Partnership Locality Plan and the Strong Communities Delivery Group (SCDG) Delivery Plan.

A partial Place Standard Consultation was then carried out within Mainland communities on behalf of the Integration Joint Board. The findings of this survey in the West Mainland were very similar to responses given by isles residents in the 2016/17 non-linked isles survey. It was therefore decided that in order to progress the work of the Strong Communities Delivery Plan and The Orkney Partnership, there would be a full Place Standard consultation for the West Mainland and Kirkwall, as the next geographic area for locality planning.

Voluntary Action Orkney in collaboration with Highlands and Islands Enterprise, Chair and Vice Chair respectively of the Strong Communities Delivery Plan, submitted a successful application for funding to the Aspiring Communities Fund to employ a Community Engagement Worker. The focus of the new role, which began in August 2020, was to plan and deliver the consultation in the West Mainland and Kirkwall. This would include involving communities in designing solutions to the issues identified in the consultation, ensuring that local people are at the heart of community planning going forward.

The two-year programme of consultation and community engagement is also particularly focused on those that are seldom heard, and those who may be experiencing any form of inequality or disadvantage, but who are traditionally under-represented in community consultations. This was to be achieved by ensuring that engagement methods used for any consultation or community work were inclusive and innovative. However, due to the Covid-19 measures in place at the time of the consultation usual community activities could not take place with the consultation carried out largely online, and so not particularly inclusive.

However, now that Orkney is beginning to move out of restrictions VAO is looking at ways to be able to engage further with communities in a safe way, to dig deeper into the issues raised in the survey and to look to potential solutions. There will also be some future work to ensure that young people, who were under-represented in the survey, are able to have their say.

This report presents the findings of the West Mainland and Kirkwall Place Standard Consultation 2021,

Your Community, Your Voice Consultation

1.1 Methodology

The consultation launched on the 22nd of February and closed on the 21st of March. Due to the COVID 19 restrictions in Orkney at the time the consultation was largely delivered online through a questionnaire on Survey Monkey. There was also an option for respondents to request a paper copies of the survey which they could post back to VAO using a pre-paid envelope provided.

The Place Standard Model was used as the basis for the survey to capture a range of physical and social aspects that could be summarised into a simple diagram. The model covers 14 different categories about place that respondents could rank from 1 (a lot of room for improvement) to 7 (very little room for improvement). There was also space to leave comments on each of the categories. The survey was completely anonymous and confidential to ensure respondents could feel they could comment openly.

The survey could be filled out by either an individual or by a group with respondents having the option of answering all the questions or selecting just the ones they were most interested in feeding back on. Demographic data was also collected including the respondents ages and postcodes, to be able to attribute data anonymously per parish. Respondents were asked some questions in addition to the Place Standard categories, including how the pandemic may have affected their responses as well as one positive thing about their community or something they'd like to see more of going forward.

The consultation was widely advertised through the local radio and newspaper. Emails were sent to VAOs mailing list as well as to statutory partners and the third sector for dissemination to their networks. Advertising via social media was used throughout the consultation period on the VAO Facebook page as well as by partner organisations. In the more rural parishes posters were used in local shops, which included the option to download the survey using a QR code.


1.2 Consultation Findings


The consultations findings are provided below with information collated from all parishes as well as information per parish. The information per parish sections includes radar charts that show the ratings for each of the survey categories. A chart of aggregated island scores is provided in Appendix 1.

The comments per parish are in the main respondents' own words and reflect the priority issues identified. Not all respondents answered all questions or left comments for all questions.


1.2.1 All Parishes

The survey generated 328 responses from the West Mainland and Kirkwall area in total. The numbers for each parish are shown in figure 8 below. Some responses were received from outside the consultation area, which were removed from the analysis for this report but the comments and rankings were saved to inform future planning in other areas. Figure 9 shows the age range of respondents.





Respondents were asked to rate how their answers to the survey may have been affected by the COVID 19 pandemic, with the option to leave a comment. The most common answer was 1 which was not at all. The comments showed that respondents had largely focused their answers on their communities before the pandemic, with some saying it had slightly influenced priority issues going forward.





Comments:

Moving Around (5)

- More joined up walking routes around town
- Traffic management/calming for speeding cars
- More benches and picnic benches
- Dedicated cycle lanes
- Better lighting in the evening for after school or work in winter
- Better path maintenance can be muddy and slippy
- More off-road walks like Crantit, routes down to Scapa etc.

Public Transport (4)

- Too expensive
- Need to extend available routes
- More bus shelters on outskirts of town
- Flexible service that can be booked in advance
- More electric, smaller vehicles as buses often seem empty
- Too infrequent
- Unreliable
- Poor Sunday service, travel in afternoons and evenings also limited
- Not always accessible for wheelchairs and buggy's
- Quality/cleanliness of buses could be improved e.g. hand sanitiser

Traffic and parking (5)

- Speeding on main routes into and out of Kirkwall
- · Petrol fumes in town centre
- · Lack of parking near pier for ferries
- · Parking issues blocking access to junctions or pavements
- Better signage for tourists
- Shortage of parking during summer
- Pedestrianize main streets

Streets and spaces (6)

- More seating and wildflower planting in town centre
- Make more use of heritage/history and creatives in Orkney to design some street art or other features
- Keep greenspaces maintained
- More bins to deal with litter
- Some run down/derelict buildings that could do with maintenance/use

Natural space (6)

- Need more places to stop and rest on paths
- More areas for wildlife e.g. verges could be left to grow where it doesn't interfere with road visibility
- Could be better access for those with reduced mobility
- Some alternative spaces like outdoor theatres or for other outdoor events/activities
- Need a car to access most places

Play and recreation (5)

- More natural play areas should be developed as part of landscaping in open areas like the Peedie Sea
- A good range of areas but not always accessible for people with disabilities
- Not a lot of parks for older children and teenagers
- Better equipment needed for playparks
- A dedicated dog park

Facilities and amenities (5)

- Pickaquoy centre is good
- Cycle routes to Pickaquoy Centre could be made safer
- Library is great
- Need more public toilets
- Good health services but mental health provision is seriously lacking there are no areas in town that provide privacy/peace during a crisis
- Need more cycle parking

Work and local economy (5)

- Economy heavily reliant on tourism
- Limited opportunities for career progression
- Lack of childcare options for school age children (5-13) means that parents are restricted to what jobs they can take
- After school care from 3-5:30pm is missing for families

- Very few registered childminders and expensive lack of knowledge from employers on how hard it is to find a childminder due to qualifications needed
- Rents are often too high for businesses to start up
- Broadband connectivity an issue
- Lack of opportunities for graduates
- Pay gap between public and private sector
- Would like to seem more affordable opportunities for people to gain new skills and for folk facing barriers to employment

Housing and community (4)

- More social housing needed
- Shortage of rental houses
- Too many second homes, holiday lets and Airbnb's
- Shortage of affordable housing particularly one bed properties
- Housing stock needs to be improved e.g. energy efficiency, insulation, green energy
- Need more support for young families to buy
- More opportunities for shared or semi-sheltered housing

Social interaction (5)

- Kirk Green or Tankerness Gardens are good meeting places but other than that not a lot of places to sit and chat
- Only option is cafes/pubs meaning you have to spend money to meet
- There could be more walking routes with communal areas and sheltered seating
- Not a lot for mixing of age groups
- Would like to see more open spaces like Liberator Development that encourages children to play and adults to come together

Identity and belonging (6)

- Historical aspects of the town are good and encourage more interaction with local history
- It's a good community in a lot of ways but there can be a tendency to resist good change, I think misogyny still exists
- Generally good involvement in the community but there is an undercurrent of prejudice against minority groups that can be seen on social media – more should be done to call this out
- I feel very welcome however it would be good to have more groups to help with meetingfolk especially for new residents

Feeling safe (7)

- Antisocial behaviour is on the rise
- Need better education, respect and understanding for survivors of abuse to feel safer
- Maybe not as safe as it used to be in the past, but society as a whole has changed
- Walking around roads at night can be scary, better lighting would make me feel safer


Care and maintenance (4)

- Residents could be better informed of changes to services such as recycling
- Public toilets could do with some maintenance
- Dog fouling is an issue
- Too much litter

Influence and engagement (4)

- Feel like no notice is taken of views given and that decisions have already been made
- Not sure how to influence decisions or to be heard need better communication
- Unsure of wider context or purpose of consultations
- Sometimes feels like a tick box exercise
- Consultations aren't always well advertised
- Consultation fatigue
- Don't always feel like action is taken after surveys

1.2.3 Stromness



Comments:

Moving Around (5)

- Roads are very narrow
- Need more cycle paths through town as it is dangerous to cycle on the road
- Path work in need of expanding and to be made more accessible
- In many places on the Kirkwall to Stromness road there is no footpath for pedestrians or cyclists
- Pavements can be slippy when wet, need better maintenance for weeds and moss
- No secure cycle racks in Stromness

Public Transport (4)

- Better frequency of routes to tourist spots would be good to allow for days out for locals as well,
 would help with parking problems at popular spots
- Want to see more electric vehicles
- Unreliable
- Not stops at south end of town
- More smaller buses to allow for more runs on more routes
- Expensive
- Not always accessible

- Times do not suit need better evening service and for getting to Kirkwall for early morning shifts
- Traffic and parking (4)
- Parking arrangements on main street too narrow and crowded can be dangerous as well as blocking access
- Lack of parking in summer months
- Improving bus services would reduce traffic
- Look into one-way system for high-street

Streets and spaces (5)

- Dog fouling and litter both persistent problems without enough bins
- More planted areas to brighten up the place
- Many derelict or empty buildings that could be used
- More trees to help with noise, wind, and air quality community woodlands or garden type walks
- · More benches along main road
- Signposts/road maps for campsite

Natural space (6)

- More benches and seating
- Community payback schemes from wind energy to fund improvements
- Mostly fantastic but need more litter bins
- Sustainable tourism strategy required for busy areas
- Wonderful but needs more public toilets

Play and recreation (4)

- Lack of music venues to practice and perform
- More clubs in Stromness after school so you don't have to travel to Kirkwall
- Of good quality but could do with more for teenagers
- Timing of facilities opening could be more flexible
- Some play spaces require upgrading and maintenance

Facilities and amenities (5)

- Could do with toilets on golf course side of town
- Not a lot open in the winter
- For a small town the facilities are good
- Encourage a variety of local shops to encourage local spending

Work and local economy (4)

- Rents for shops too high which puts off business
- Create hot desking spaces to mitigate isolation from remote working
- Childcare difficult to find need more registered child minders
- Economy dependent on tourism develop economy on other industries like technology, food and energy production
- A lot of part time posts or short-term contracts
- Economy seems to be centred on tourism

Housing and community (4)

- Lack of housing for first time buyers and young folk
- A lot of holiday homes/second homes/Airbnb

- More eco/affordable homes needed
- I had to move 3 times in one year to find somewhere long term to rent demand is incredibly high and competitive
- · Rents are too high
- Electricity costs are high
- Rental properties often damp, mouldy and in poor condition
- More sheltered housing needed
- Renovate old properties
- Lack of parking to some homes in town

Social interaction (5)

Not many options other than cafes and pubs to meet

Identity and belonging (6)

- Generally welcoming and inclusive, there will always be those who aren't
- A good sense of community
- There's always more that can be done to make people feel welcome and wanted


Feeling safe (7)

- More street lighting in darker areas of town
- Feels very safe

Care and maintenance (4.5)

- Dog fouling is a problem
- Too much litter
- Recycling is difficult
- Influence and engagement (4)
- · Confusing landscape of who is responsible for what
- Need more transparency and openness
- Communication is poor
- Not sure how to find out what's going on
- · Feel disengaged and disillusioned

1.2.4 Harray and Sandwick



Comments:

Moving Around (3)

- · Lack of street lighting dangerous in the winter
- Walking routes not suitable for disabled
- Not enough seating for those who want to rest or enjoy the view
- Roads are too narrow
- No cycle lanes
- Erosion on some coastal walking paths
- Walking, cycling or horse riding on busy roads feels dangerous drivers are not always considerate at giving room and drive too fast
- Opening up more tracks to create bridle tracks through the countryside off the main roads also more joined up paths in hills/countryside
- Busy roads with no pavements are a challenge with children
- Not enough way markers for tourists
- Too many speeding cars

Public Transport (1)

- Cost and travel to bus stop can be a difficulty
- Living in Harray and working in Stromness it is impossible to get to work by public transport for an early start
- Public transport to Harray, Birsay or Sandwick to Kirkwall or Stromness is unreliable
- Need more seating at bus stops
- Connectivity is limited to rural locations only 2 per day and nothing after 5:30pm from Kirkwall to Dounby/Sandwick
- Difficult to use for children when attending activities in town in the evening
- Limited night service on all connections
- A catch 22 situation: some people are more likely to use cars as buses aren't frequent but because the buses aren't frequent everyone uses their cars

Traffic and parking (4.5)

- Reasonable free parking in the area but can become crowded in the summer
- More considerate driving needed during bird breeding season
- Not a lot of parking in and around Dounby centre and it's a busy road to cross with fast moving traffic
- Information campaign for driving on single track roads
- Some parking in villages can obscure oncoming traffic
- Car parking signage in town is too vague
- Speeding on Harray straight

Streets and spaces (4)

- Nothing to accommodate groups meeting outside in Dounby need more shelter for poor weather
- Dounby could have some more trees or park/garden to improve the view
- Should be incentives for folk to support local business
- · A lot of uninhabited houses and semi-derelict buildings
- More seating in countryside spots
- Planting wildflowers and bulbs to improve views in village

More dog waste bins

Natural space (7)

- · Lack of public toilets
- Some more accessible routes for those with mobility issues would be good
- Would benefit to have a greater network of footpaths
- Need to preserve what we have

Play and recreation (5)

- Lack of public transport and activities for teenagers can make them feel trapped
- Harray hall a good space normally
- Apart from community halls I'm not certain there's enough facilities for meeting together, I think sport is well catered for but can be expensive
- More investment in play facilities such as swings, climbing frames and slides as well as an allweather pitch
- Always room for improvement however the community school and new church provide good spaces for groups and activities

Facilities and amenities (6)

- Dounby centre is a good resource, though longer opening hours would be good
- Need to have a car to access a lot of facilities
- Very good facilities in Kirkwall and some in Stromness but have to hang around to get home via public transport
- · Not enough public toilets

Work and local economy (5)

- Jobs can be difficult to come by and are not usually competitively paid
- Orkney college provide good set of options would be good to have more wide ranging courses in traditional skills
- Need to review work practices like relief zero-hour contracts
- Empty shops could have lower rents to encourage pop ups
- A lot of work is seasonal which is not helpful for all year round
- Many young folk leave the island for better paid, more interesting and varied opportunities
- People can often be under-employed: working multiple jobs or in unstable employment

Housing and community (4)

- Rented accommodation hard to come by
- Building own home limited by building rules/regulations
- Need more homes suitable for elderly people so they can receive care at home
- Rent is expensive and there is not much opportunity for group renting
- Not enough good quality homes for rent

Social interaction (5)

- Travel to events can be a problem, especially for older people
- Not enough facilities for informal meetings
- Unaware of any formal meeting spaces for young adults
- Not many spaces that can be used in all weathers
- Not always many opportunities to meet folk except in the pub

 Summer festivals good for attracting folk from all over the island, different events might also be good for variety

Identity and belonging (6)

- I do have a sense folk help each other out
- A strong sense of community but some outdated ideas
- Quite accepting place, schemes such as youth forum could be expanded to help with inclusion would also benefit from an Orkney pride for example
- · Feels less so than in the past

Feeling safe (7)

 This community feels on the whole safe, the danger is traffic on the roads and internet/phone scams which are worrying


Care and maintenance (5)

- Dog fouling is a problem
- Would like to see better recycling
- Littering a problem particularly on country roads due to wind
- Vandalism a persistent problem

Influence and engagement (4)

- People often have to be proactive to be involved
- Need a more joined up approach to outreach to update people on big decisions/projects
- More accessible options to amplify other voices
- Feel that councillor are not always visible or accessible
- Not always sure how to be listened too
- Website design can make it hard to find information
- Happy to take part in further surveys, focus groups can also be helpful to gain insight
- If public see new initiatives and improvements people would be more inclined to engage in future
- Decisions feel like they are made behind closed doors

1.2.5 Birsay



Comments:

Moving Around (4.5)

- Roads busy in summer
- Cycling, walking and horse riding dangerous
- Roads too narrow
- Difficult to pass cyclists in groups
- Too many speeding cars
- Limited passing places

Public Transport (1)

- Limited timetable
- Times not ideal for getting to work or for evening events in town
- Not easily accessible for everyone
- Not affordable
- Put on more smaller buses rather than few large ones potentially electric vehicles
- · Request bus service using smaller vehicles
- Without better support and transport, I won be able to stay here when I stop being able to drive

Traffic and parking (5)

- Parking in towns can be a problem in summer and during peak times
- Would like to see more 10 minute free parking
- More formal parking at popular walks and viewpoints needed to avoid blocking passing places

Streets and spaces (5)

- Could be better signage
- Preserve landmarks and historical sites for the future
- Have more shelters for bad weather made from local materials in public spaces
- More public toilets and bins

Natural space (6)

Wonderful green space however can be difficult to access for those with disabilities

Play and recreation (5)

- Generally, a good range of activities in the West Mainland but it sometimes feels as though there are more opportunities in Kirkwall which requires travel
- Play parks could be better maintained
- Not a lot of options for teenagers
- Difficult to attract classes or group activities to hire the local hall due to rural location

Facilities and amenities (4)

· Public toilets need to be upgraded

Work and local economy (4.5)

- Need more support for businesses to grow and stimulate employment
- Opportunities tend to be centralised to Kirkwall
- Some low paid jobs and some very high paid jobs but little in between

 Could have support from college to help young people adapt to new working practices i.e. working from home

Housing and community (6)

- Too expensive
- Need to renovate derelict properties to increase stock
- Improve homes self-sufficient using renewable energy
- Difficult to find affordable private rental
- Limited social housing in rural areas

Social interaction (5)

- Wide array of clubs and societies
- Lack of evening activities

Identity and belonging (5)

Very community minded

Feeling safe (7)

· Feels very safe within the home, but not on the roads


Care and maintenance (5)

1.2.6 Evie and Rendall



Comments:

Moving Around (4)

- Not easy to walk along the side of the road as verges are high and muddy not very accessible for everyone
- Plenty of walking routes off road but poor for cycling
- For the less able there are not a lot of pavements in Evie not suitable for walking with children or wheelchairs
- No benches if someone wants a seat while out walking
- More info needed for drivers to explain to be aware of folk walking or cycling on country roads can be dangerous due to high speeds

Public Transport (4)

- Not frequent enough
- Not reliable there have been times when the bus hasn't turned up
- Wish the bus was not a coach unnecessary from an economic and environmental point of view
 smaller mini buses would be more appropriate
- Larger buses on narrow roads are mostly always empty look at having smaller electric vehicles that would run more regular i.e. from Evie/Costa to allow travel to doctors surgery in Dounby
- Last service at 5pm
- Not accessible
- The price of tickets means it is cheaper and also more convenient due to the timetable to take the car
- Connections are not always available except to get into Kirkwall

Traffic and parking (4)

- Need to promote Orkney as a clean transport destination more electric chargers, electric transport and ferry's
- Encourage use of electric vehicle to overcome air quality problems in town
- Speeding
- A lot of cars in the area as buses don't fit with nursery times etc.

Streets and spaces (4)

- Kirkwall and Stromness town projects doing well to improve and preserve nature of the towns
- Too dangerous to walk at night
- Uneven paving slabs in towns a health and safety concern
- Businesses need to be supported to keep trading and not leave shops empty

Natural space (7)

- In favour of green energy but better planning needed for turbines
- One of the most beautiful locations to access natural spaces but wouldn't say it is accessible to all
- Litter is a big problem

Play and recreation (4)

- Good accessibility to them in Kirkwall or Stromness if you have your own car
- Community park in process of being rebuilt, will be good when complete
- Not affordable for a lot of residents

- Lack of shelters for people to sit outside
- Toilets at Evie would benefit from having marked out parking
- More opportunities for use of recreational outdoor space for young people or for adults with disabilities
- Use of centre at Dounby a valuable resource

Facilities and amenities (4)

- Rooms for improvement for toilet facilities that are fully accessible
- Good facilities but access limited by public transport
- Doctors surgery shutting is very inconvenient
- Broadband issues

Work and local economy (3)

- · Lack of childminders/afterschool clubs in rural areas
- Not many opportunities locally
- Opportunities in Kirkwall or Stromness provided you can travel

Housing and community (4)

- Lots of young couples and families have not been able to stay in the area due to lack of housing opportunities
- Not enough smaller accessible housing for folk as needs change
- Private sells often unaffordable
- Difficult for anyone wanting to build a new home due to planning regulations
- Lack of housing to rent

Social interaction (5)

- A few opportunities for different age groups in Evie, tend to rely on volunteers and enthusiastic organisers
- Community halls are good locations for broad range of ages to mix
- Fortunate to have a new community area withing the school
- No café or pub for folk to meet casually

Identity and belonging (5)

- A loss of identity and cohesion e.g. no harvest homes or ceilidhs and nothing to replace it
- Needs enthusiastic commitment from community
- Strong feeling of community depending on how much you want to be involved

Feeling safe (7)

Feel safe to walk at any time of day or night

Care and maintenance (5)


- Usual problems with litter and dog fouling
- Would like to see recycling centre in Dounby

Influence and engagement (5)

- Sometimes feel like people in power have a job to do rather than listening to what the public want
- Never know when community council meetings are happening and no recent minutes online to see what has been discuss or decided

- Decision making too centralised
- Don't often see any outcomes or difference achieved by surveys

1.2.7 Firth and Stenness



Comments:

Moving Around (1)

- Need more cycle routes
- · Main Kirkwall to Stromness road very busy at times with no spaces for walking or cycling
- No cycle/walking near main tourist attractions like Brodgar or Maeshowe
- Main road dangerous to walk on with high verges so for bikes, prams, wheelchairs it is impossible to get safely off the road
- No speed checks when entering Finstown 30mph zone
- More benches in towns
- More passing places on some routes

Public Transport (6)

- Timetable restricted in some west mainland areas
- Expensive
- Would like to see electric vehicles
- Poor provision in evenings

- Limited to Kirkwall and stromness without driving they are hard to reach
- Play park at school in Stenness is dated and equipment is in need of repair it is a great space though and community garden is lovely in spring and summer
- Traffic calming on main road to make it safer for children to play
- Lack of opportunities in Harray
- Good play space for families in community play park but little or nothing for teenagers

Facilities and amenities (5)

- It would be good to have facilities that deal with healthcare, including mental health provision, particularly for LGBT+ people
- Community room is used by different groups for afterschool activities, but a car would be necessary to get there in the evening
- Available in Kirkwall or stromness if you have transport
- Rooms in community schools/centres are expensive to use
- Main problem is access by public transport

Work and local economy (5)

- Finding work to fit around education is difficult
- Childcare is extremely difficult to find
- Access to this in Kirkwall but not in my immediate community
- Limited options for young people if they can't easily travel to town

Housing and community (5)

- Not enough housing for renters, low income, or first-time buyers
- Too many self-catering or second homes which are only occupied a few weeks or months of the year
- More affordable housing would help support the local school
- Difficult for young families to afford housing in Stenness other than OHAL there are few options
- · Concerned about fuel usage improved fuel costs and insulation needed

Social interaction (6)

- Less outdoor spaces which isn't great in winter
- Some availability to meet but mostly in Kirkwall

Identity and belonging (7)

- Strong feeling of place and belonging
- There is some community feeling but this has lessened over time
- Generally a good community but isn't always the best in terms of openness and acceptance of folk who are different


- Better lighting in car park/toilet/pier area


