## The Big Lottery Fund Scotland

A review of its investment in family support projects had recently been published.

The report makes a number of interesting points, notably that the independent nature of voluntary organisations is a key strength that allows them to adapt to each service user's unique circumstances. It also identified that some key challenges to effectiveness can be a lack of capacity to meet demand and demands placed on the organisations by having to seek external funding.

The report highlighted the importance of the voluntary sector in delivering services to families experiencing a range of hardships and that the sector's ability to work in partnerships with statutory bodies as well as building strong relationships with service users was of utmost importance in improving the lives of vulnerable people.

## The Scottish Land Fund

has now been extended for a further year, to March 2016, with an additional £3m allocated for projects. Support can be given for purchase costs, including fees, together with revenue support for up to 2 years, maximum £50,000. This is intended to help applicants further develop their plans for the land once it has been purchased.

The Fund can be used for properties that are subject to the Community Right to Buy legislation, as well as general land and property that comes to the market or is subject to private negotiation. It can also be used to acquire assets from the Council through its disposal of surplus assets programme.

Telephone enquiries can be made to the Big Lottery on 0300 123 7110. Once the project and applicant has been deemed eligible the applicant is referred to a Scottish Land Fund Advisor, who will make contact with them and help them with the development of their project.

## Regulators consult on SORP

Charities across the country are being urged by the Regulator to play their part in reviewing how charity accounts are prepared.

The Office of the Scottish Charity Regulator (OSCR) and the Charity Commission for England and Wales have announced a consultation on the new Charities SORP (Statement of Recommended Practice).

The micro-site, [www.charitySORP.org](http://www.charitySORP.org) allows charities and their advisors to give feedback and to download the SORP modules that are relevant to them.

## Legal Action against Charity Trustees

There has been a drastic rise in legal action against trustees says a leading expert. The High Court reported a 14% increase in action against Trustees in relation to the Trust Property and Investments for the year 2012, a 658% rise since the collapse of Lehman Brothers in 2008 and the start of the global financial crisis.

Charity Trustees who are personal trustees and do not have the protection of a 'Company Limited by Guarantee or Charitable Incorporated Organisation' may suffer exceptionally serious consequences, as they could find themselves personally liable for the losses and actions of their investment managers.

The Charity Commission published guidance for trustees in October 2011 and set out that if a charity trustee delegates their investment duties to an investment adviser, then failure of their Duty of Care could leave them personally liable for any actions and losses the adviser incurs.

### **HMRC consultation**

HMRC has recently launched a public consultation on its proposal to make the qualifying rules for the Community Amateur Sports Scheme (CACS) clearer.

The scheme provides a number of charity-type tax reliefs to support local amateur sports clubs. These include business rates relief, relief from Corporation Tax on certain types of income, Capital Gains and Gift Aid relief on donations of money by individuals. In order to access these reliefs, clubs must meet certain conditions and must register with HM Revenue and Customs.
