

# **Personal Safety Course for Women**

This empowerment-focused, trauma-informed Personal Safety course will be delivered in Orkney on 1 and 2 May 2024 (the venue is still to be confirmed)



The training is split into theory and practical sessions:

- The theory side covers the Law regarding Self Defence, Reasonable Use of Force, Warning Signs and Danger Signs (so you can recognise when an attacker is about to attack before it happens), Voice Control, Defensive Stance, the T-Zone (so you know where to effectively strike an attacker), Improvised Weapons, and various scenarios such as what to do if your being followed.
- The practical self-defence side covers breakaway techniques from a wrist grab and clothing grab, escape from a strangle hold, how to defend against a frontal attacker and a back attack, and defence against a ground attack (both a physical assault and, if required, a sexual assault).

Although the day flies by, some groups need a shorter course. A 3hr course is mainly theory with a small amount of self-defense, A 6hr session allows plenty of time for questions and advice, as well as self-defense techniques and theory.

# Free Child Impact Assessment (CIA) toolkit training

The Orkney Community Justice Partnership (OCJP), in conjunction with Families Outside are offering free training sessions to professionals across a broad spectrum of agencies who support children and young people in Orkney. The sessions are independent of each other and usually are charged however the OCJP has secured this on behalf of Orkney at no cost.



The training is taking place on Tuesday 19 March 2024 in the St Magnus Centre Friend's Room, Palace Road, Kirkwall, KW15 1PA.

Morning Session - 09.30am -12.00pm

Examine the impact of the justice system on families from arrest all the way through to release and will help professionals, across multi disciplines, develop their understanding of contributory factors to consider when supporting families as they navigate this experience.

Afternoon Session - 13.00pm - 15.30pm

Focus on the impact of the justice system on children and young people and how the Child Impact Assessment (CIA) toolkit is a useful tool to help professionals guide a conversation to enable children's rights to be upheld when someone in the child's life is involved in the justice system.

Places are limited to 30 participants and will be allocated on a first come first served basis, however it is intended to achieve an even distribution of this training across the wider partnership of agencies and professionals who support children and young people in Orkney.



## **Small Grants Scheme**





We are grateful to both Repsol Sinopec and Liam McArthur MSP for their donations which the VAO Board has decided to disburse as grants in order to support the work of small, community groups.

Constituted groups with charitable objectives (excepting party political groups), are eligible to apply for a grant of up to £500 maximum for a project or activity to help their community.

Priority will be given to organisations that have not previously received an award.

Recipients of grants must claim the total sum awarded by 31 March 2025.

The deadline for applications is 5pm on Friday 1 March 2024.

## **Empower grants programme**

**★ BANK OF SCOTLAND**Foundation

Bank of Scotland Foundation recognises the profound impact that the cost of living crisis is having on people across Scotland. To ensure funding can reach those in real need, the Empower grants programme for 2024 will solely focus on helping charities who support vulnerable groups/people.

The Empower programme provides unrestricted funding. Unrestricted funding gives charities much greater scope to cover all essential costs and deal with challenges quickly and effectively. Unrestricted funding can be used towards core costs, delivery costs, project costs and/or general running costs enabling charities to use their funding in the way that helps them best.

To be eligible for this programme:

- your charity must have a minimum of 3 years accounts lodged and checked at OSCR.
- your charity income must be between £150k £500k per year as stated in your most recent accounts that have been lodged and checked at OSCR.
- your charity must operate in Scotland.

All applications must be submitted online by 12 noon on the closing date of Thursday 15 February 2024.

## **Self-Management Fund**

The Self Management Fund is administered by the ALLIANCE, on behalf of the Scottish Government. It aims to support projects that put people and communities at the heart of prevention and self management, and is inviting applications for work that seeks to:

- Support people living with, or who might be at risk of developing, long term conditions to be better able to self manage and/or reduce risk factors.
- Support people who experience barriers to accessing health and social care support and services, due to geographical, social, or economic factors to feel better able to self manage through direct support or support to access services.
- Support people who are waiting for a specialist health or social care intervention or rehabilitation support through enabling them to develop self management capabilities while awaiting treatment.
- Support disabled young people or young people living with long term conditions or unpaid carers to understand the importance of self management and to develop skills which maximise their health and wellbeing.

The Grant Allocation Panel is particularly interested in hearing from projects which support people with a range of conditions and/or multiple conditions and can demonstrate approaches that see the whole person and their holistic needs. In addition, the panel will be looking for projects with strong potential to generate new learning for self management practices.

Two levels of grant are available - small grants of up to £15,000 for up to one year and large grants of up to £120,000 for up to three years.

The fund is open to all community and third sector organisations in Scotland, working to support disabled people, people living with long term conditions and unpaid carers regardless of their membership of the ALLIANCE.

# The Happiness Fund

The Happiness Fund is available to enable and support projects which improve mental health and wellbeing, inclusion, learning and skills development in local communities.

The aim is to build happy, strong, resilient communities by supporting grassroots, not-for-profit projects that enable sustainable outcomes in:

- Mental health Wellbeing & happiness
- Inclusion
- Learning and skills development

The fund is intended to help new groups and activities, to be successful. Applicants will need to indicate how the activity/group can become self-sustaining or able to attract funding from other sources in the longer term.

The fund will award £5,000 twice a year - allowing up to two different projects/charities or CIC's per year to apply. You cannot re-apply if you have won funding from the Happiness fund in the last 24 months.

### The Steel Charitable Trust

Applications must be for charitable purposes that fall into one of the five core categories below; applications for purposes outside these categories are only permitted at the direct invitation of a Trustee:



- Arts and Heritage
- Economic or social disadvantage
- Education
- Environment
- Health

There are no focus areas within the categories of Arts and Heritage, Education or Environment.

Applications for the Health category, must have a focus on one of the following:

- programmes and activities that aim to support, maintain and improve mental health in any demographic
- health care for older people

Applications for the Social or Economic Disadvantage category, must have a focus on one of the following:

- disadvantaged children
- housing and homeless people

Applications can be made at any time and are normally considered according to the timescales shown:

- 16 January 11 April (reviewed mid-June for decisions early July)
- 16 April 15 July (reviewed mid-September for decisions early October)
- 16 July 15 October (reviewed mid-December for decisions early January)

Applicants are encouraged to submit applications early in the application period to allow more time for their review.

The next application deadline is 11 Apr 2024

# **Community Heat Development Programme**

If you want your community to go low carbon, support is available from The Scottish Government's Community Heat Development Programme. Delivered by Local Energy Scotland, it supports communities (including groups of householders and community organisations) to develop their ideas for locally-generated, low and carbon heat projects.

Need some inspiration? Some examples of applications in the pipeline include:

- Twelve neighbours in a block of flats investigating low carbon options to replace the block's ageing gas supply
- Residents in a tenement block are considering installing ground source heat pumps in its shared ground
- A community is looking at the coordinated, collective purchase of air source heat pumps to help make the process smoother for all

Successful applicants will receive technical support to consider the feasibility of their project idea and will give advice on next steps, including any potential routes for further funding.

# Orkney Local Employability Partnership Innovation Fund (Parental Support)

The innovation fund is available to third sector partners within Orkney that work with parents/families within the NOLB priority groups ( Lone



parent families, families with a child under one, families where a parent is under 25, households in which a parent or child has a disability, larger families (3 or more children), and minority ethic families) and support them to develop confidence, skills, networks etc to make positive future steps.

Organisations can apply for up to £10,000 and the deadline for applications is Thursday 29th February 2024.

## #AndSheCycles Funding

This fund is open to groups of young women such as guide groups, school groups and youth groups.



The funding is available to help these groups develop and implement plans to help break down the barriers young women face when choosing to cycle.

Up to £2000 per group could be available to help purchase necessary equipment to help support more young women cycling.

- bikes
- helmets
- bike pump station
- secure bike storage

# **Business Energy Efficiency Grant**

Orkney businesses can apply for grants up to 50% contribution to invest in measures to progress towards net-zero carbon emissions and result in long-term sustained reduction in energy bills. The minimum project spend is £2,000 offering a grant of between £1,000 up to a maximum of £15,000.



- Applicant businesses must be based in, and trading in Orkney for a minimum of 12 months
- Businesses must make a 50% contribution to the costs of their project.
- Charities, social enterprises and third sector organisations carrying out economic activity with employees may also apply.
- Applicant businesses must demonstrate sales income for at least 12 months.
- Operate from commercial premises in Orkney with a legally constituted signed lease, rental
  or license agreement for more than 5 Years. Obtain written permissions from landlord to
  make changes and seek permissions from OIC to undertake the work.
- Applicants must be a UK resident with the right to work in the UK.

- Businesses must meet the European definition of an SME in relation to employees, balance sheet and turnover.
- All industry sectors can apply.

### Eligible costs:

- Purchase of equipment that would contribute to demonstrable energy saving.
- Improving roof and building insulation, draught-proofing or installing new doors, or double/secondary glazing.
- Renewable energy installations (for example, solar, ground or air source heat pumps. Solar and Air to Water heat pumps) – Work to be carried out by an MCS Installer and systems installed to MCS standard (MCS certificate provided when install is complete).
- Waste management or recycling projects.
- Energy efficient lighting systems.
- Low energy heating.
- Implement new business processes that will help reduce business energy costs.
- Other significant project costs deemed to be acceptable by the Council that aligns with the grant scheme intentions.



## **Open Grants Programme**



The Clothworkers' Foundation award grants to UK registered charities, CICs, and other registered UK not-

for-profit organisations (including special schools). Grants are awarded towards capital projects, which they define as:

- Buildings: purchase, construction, renovation or refurbishment.
- Fittings, Fixtures, and Equipment: this includes but is not limited to office
  equipment/furniture, sports/gym equipment, digital/audio visual equipment, software and
  websites (more guidance on digital infrastructure can be found here), garden equipment,
  specialist therapeutic (excluding medical) equipment. It does not include equipment for oneoff use, or which will be given to service users for personal use on a permanent basis.
- Vehicles: This includes a minibus, car, caravan, people-carrier, or 4X4. We are unlikely to fund the total cost of a new vehicle and do not provide grants towards vehicle leasing.

Their eligibility criteria for applications has expanded to include digital projects beyond hardware. They will now consider funding one-off costs for some types of digital software and products. The aim is to enable organisations to be more sustainable, engage more people more effectively, and support their staff and volunteers to do their work more efficiently.

They fund both large and small projects. The size of grant awarded depends on a number of factors including the size of the organisation and the cost and scale of the capital project.

To be eligible the projects must fit within one or more of the Foundation's specified programme areas.

There are no application deadlines and you can submit an application at any time.

## **Chances for Children**

Individually tailored grants of up to £2,400 for children and young people who have experienced a crisis that has recently had a significant and enduring impact on their wellbeing and educational engagement. Buttle UK fund items and activities to help improve children and young people's wellbeing and increase their capacity to engage in education and learning.

They only accept applications from frontline professionals working for a registered charity, housing association or public sector organisation who:

- are working directly with the children/young person
- have made a full assessment of the child's or young person's needs
- have carried out at least one home visit (optional for schools and colleges)

If successful, the professional will need to manage the funds, upload receipts within 8 weeks of receiving the grant, and complete an evaluation survey.


Children and young people must meet the following criteria:

- Aged from 2 to 18 (including 18 year olds) if living with parent or carer or aged 20 and under if living independently with little or no support from their family
- Accessing education, learning or training
- Living on a low income and experiencing financial hardship
- Have experienced a crisis that has recently had a significant and enduring impact on:
  - their wellbeing
  - their development and education
- The family or young person has recently taken action to improve their situation, are actively engaging with support and are moving on from the crisis.

## **Tesco Stronger Starts**

Tesco Stronger Starts fund thousands of local community projects across the UK. Priority is given to projects that provide healthy food and/or activities that boost children and young people's mental and physical wellbeing and not just from schools.



The scheme provides grants of up to £1,500 to local projects from across the whole of Scotland. It is open to all local authorities, registered charities and not-for-profit organisations. Applications needed now from youth groups, schools, sports clubs, and more.

## **Historic Environment Grants Programme (HEG)**

The programme can support a wide range of projects which clearly relate to and will benefit Scotland's historic environment. To be eligible, all projects will need to:



- clearly relate to a Scottish historic environment asset (tangible or intangible)
- be able to demonstrate how they will contribute to HES Grants Priorities. View the priorities by visiting the <u>Historic Environment Scotland website</u>.
- offer good value for money
- be able to demonstrate that they are deliverable
- have not started (unless discussed and agreed by HES Grants Team)
- not already be funded by a City Heritage Trust or through any of our other funding programmes

Projects should be focused on an aspect of Scotland's historic environment, from the tangible (e.g. historic buildings, ancient monuments and archaeology, designed or cultural landscapes and historic gardens and battlefields) to the intangible (e.g. historic environment skills, stories and traditions).

There are three different funding streams under the Historic Environment Grants (HEG) which are:

- Express Grants (£1,000 to £25,000)
- Small Grants (£25,001 to £100,000)
- Large Grants (£100,001 to £500,000)

# **BBC Children in Need Emergency Essentials Programme**

The programme supports children and young people who are facing exceptionally difficult circumstances and is delivered by Family Fund Business Services. It provides items that meet a child's most basic needs such as a bed to sleep in, a cooker to provide a hot meal and other items or services critical to a child's wellbeing.



Eligible organisations can apply for a grant on behalf of the children they support. When applying on behalf of a child or young person, referrers must ensure that all possible statutory funding has been explored and exhausted before making an application to the Emergency Essentials Programme.

The programme awards grants for critical household items, typically:

- Cookers
- Fridges, freezers and fridge-freezers
- Washing machines and tumble dryers
- Children's beds and bedding
- Kitchen equipment and small appliances
- Furniture
- Clothing
- Baby equipment

Applications must be completed by a registered referrer who is part of an organisation that is supporting the family or young person and capable of assessing their needs.

# **Urgent Assistance Fund**

Aberlour's Urgent Assistance Fund can provide immediate relief to families with children (aged 21 and under) who are suffering extreme hardship. This support is usually via cash grants to assist with a range of needs, such as food, utilities, clothing, bedding, appliance repairs, replacement of appliances that have failed, or other essentials (excluding carpets, floor coverings or electronic devices).

Applications must be endorsed and submitted by a sponsor, acting in their professional capacity.

Available funds are limited and all applications will be evaluated against evidence of a family's financial status. If you receive an award from the Urgent Assistance Fund you cannot re-apply for a period of 1 year or in some instances up to 2 years.

To qualify for cash grants from the Trust:

- There must be a child in the family who is 21 or under.
- That child must be suffering extreme hardship.
- Grants are made at the discretion of the Trust.
- A sponsor must submit a fully completed application via the web application form. If applications are incomplete, they may be rejected.

# **National Lottery Community Fund**

The National Lottery Community Fund have shared their new 2023 - 2030 strategy 'It starts with community'. They are focusing efforts where there is greatest need with an ambition to 'create resilient communities that are more inclusive and environmentally sustainable, funding activities and organisations that strengthen society and improve lives across the UK.

The National Lottery Community Fund distributes over £600m a year to communities across the UK, raised by players of The National Lottery. They are open to all applications which meet their criteria, including supporting people and communities most adversely impacted by the pandemic.

#### Cost-of-Living Support Scotland:

Grants from £10,001 to £75,000 to help support individuals, families and communities currently experiencing hardship as a result of the cost-of-living increases.

### Young Start:

Helping young people aged eight to 24 to become more confident and play an active part in realising their potential.

WHP Telecoms, the Infrastructure Provider for the Scottish 4G Infill (S4GI) programme, has launched a Community Benefit Fund, committing 5% of all rents received on S4GI infrastructure to support this. The S4GI programme is a £28.75 million investment that is delivering 4G infrastructure and services in up to 55 areas across Scotland where it is not commercially viable to do so.

## The Conservation Volunteers (TCV) (): Chestnut Fund

The Chestnut Fund is part of TCV's commitment to support Community Network members. The fund makes grants available to encourage and enable community groups to carry out conservation activities. The applications are considered and administered by TCV Chestnut Fund Committee.



The grants fall into two categories:

• Start-up grants: These are for groups who have little or no money when they are first set up and are available to groups in their first year of existence. The grant will enable them to begin practical work and will cover administrative expenses, e.g. postage, publicity, hire of meeting rooms, telephone bills and/or insurance fees.

The maximum grant is £160.

• **Support grants**: These are for groups who have little or no money for tools, equipment and training. This grant is available to all groups, regardless of how long they have been constituted. Groups within their first year can apply for both the start-up grant and the support grant.

The maximum grant will be £350.

## **Motability's Research Grant Programme**


